UK Government War Crimes

Event Number 264 of 23rd March 2009

Thank you for your response to the above complaint (dated 7th August).

I was surprised at your response as David Cutler stated in his letter to me, which I trust you have seen a copy of, that "... I do not believe this is a matter for Suffolk Constabulary to investigate..." and that he would "...not be recording any allegations of crime in response to this matter...".

This surprised me, as I understand (as pointed out to David Cutler in an earlier correspondence) that The [Police Reform Act 2002](#) requires the constable of a territorial police force to take the following oath:

"I, .. <Officer's Name> .. of .. <Police Service> .. do solemnly and sincerely declare and affirm that I will well and truly serve the Queen in the office of constable, with fairness, integrity, diligence and impartiality, ***upholding fundamental human rights and according equal respect to all people***; and that I will, to the best of my power, cause the peace to be kept and preserved and ***prevent all offences against people and property; and that while I continue to hold the said office I will to the best of my skill and knowledge discharge all the duties thereof faithfully according to law.***"

Presumably as a constable David Cutler took this oath but he evidently does not stand by it. Not only has he broken his oath but the common law has clearly been broken via these reported war crimes and even under the civil legal system of Acts & Statutes 'given the force of law' by this society that we live in, the alleged war crimes have evidently been committed and the 'civil law' has clearly been broken, most notably by contravening sections 51 & 52 of The International Criminal Courts Act (2001).

There seems to be no point in establishing a force of Police defined by Blacks Law Dictionary as "...Peace Officers responsible for preserving public order, promoting public safety and ***preventing and detecting crime...***" and ensuring that these officers swear the oath I quoted above, if this oath is to be ignored once a government minister

becomes the subject of alleged crime?

By refusing to investigate these crimes David Cutler and Suffolk Constabulary are giving tacit approval for ministers to break the law without punishment.

Further more, in contrast to the comment in your letter to me that “... *David Cutler was in fact correct in suggesting that you refer this matter to the Metropolitan Police...*” he did nothing of the sort. *I asked him if I should do this when I wrote “...as you have stated you will not investigate, as you do not believe it is a matter for your constabulary, perhaps you would enlighten me as to which constabulary of the UK it is a matter for. Would perhaps the Metropolitan Police cover the area of Westminster where in effect these crimes were committed? Please let me know by return which force I should continue this case with...”*

He replied that “...*the decision to refer this matter to the Metropolitan Police Service is entirely a matter for yourself...*” so I am at a loss to see how you can suggest that he correctly advised me to do this. **Please confirm that you have seen and read the preceding correspondence** because if you have not you will have missed some important information regarding this complaint against David Cutler.

Also please note that I have made a similar complaint against an officer within the Metropolitan Police District who has also declined to investigate these serious accusations having been sent the same material, so I ask that you thoroughly investigate the complaint within Suffolk rather than passing it on as an issue to the Met, as I shall be following it up separately with them myself.

The law states that these war crimes should be reported by any citizen to any police force within a country housing people who have committed these offenses so I believe I was entirely correct in reporting the matter to Suffolk Constabulary in the first instance.

I shall be happy to forward you copies of the previous documents if you have not seen them.

I look forward to your reply.
